SUBJECT: NYARNG AGR Continuation Board for Initial Entry Soldiers (CY-19)

1. References:

- 2. In accordance with (IAW) the references above, you will be considered for 6 year continuation in the AGR Program by a board scheduled to convene 18 June 2019. The board will confirm that you meet the standards for continuation and that your performance during your initial tour merits continuation in the AGR Program.
- 3. The initial Tour Continuation board is conducted in an electronic format which means you will not appear before the board. The board will review your continuation packet which will include your validated record brief (DPRO), your DA Photo (iPerms), your current and complete evaluation history (iPerms), your current Individual Medical Readiness Record (IMR) (MEDPROS), your APFT history and your HT/WT and body composition history (RCAS). It is highly recommended that you ensure that all of the above systems are updated. Please coordinate with your Unit Admin to ensure that this is completed prior to the suspense date.

- 4. Even though the board is in electric format it is still required to submit a DA 4836 (if Enlisted) for extension to reflect new ETS date (if continued), OER's/NCOER's that are not in iPerms, and a recommendation from your Director/Commander.
- 5. Your Director/Commander will provide in your statements to the board that you meet the following standards (or not) with extenuating circumstances as applicable:
- a. You cannot be subject to involuntary separation prior to the end of your current tour. Involuntary separation includes Mandatory Removal/Retirement Date (MRD) or reaching the Retention Control Points (RCP) for your current grade.
- b. You must be Duty MOS Qualified and assigned to a position at or above your current grade and hold the required security clearance.
 - c. You cannot be flagged IAW reference 1c. (Non-Waiverable).
 - d. Meet APFT and Army Body Composition Standards IAW reference 1d and 1e.
- e. You have not had any derogatory performance actions or misconduct occurring during your initial tour to include but not limited to a referred evaluation IAW reference 1g, civilian convictions, violations of UCMJ, administrative memorandums of reprimand, or be barred from reenlistment.
- 7. The Adjutant General (TAG) has the final approval/disapproval authority for all AGR continuations. Upon TAG's determination on your continuation, you will be notified in writing. Enlisted Soldiers selected for continuation are contingent on a 6 year extension. Soldiers not selected for continuation will be released from the AGR Program within 120 days of TAG approval and revert to traditional status.
