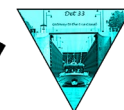
“The group ‘A15 For Action’ [announced](#) a “coordinated multi-city blockade” on April 15 at multiple ports around the world in solidarity with Palestine. The group is [calling](#) for a shift in tactics away from “symbolic actions to those that cause pain to the economy” and said they will disrupt and blockade economic logistical hubs and the flow of capital as a means to achieve their goals. Previous disruptive actions at ports in Oakland, California, and Melbourne, Australia are cited as recent successes in the call to action.

Information received from our DOT partner/Regional Emergency Transportation Representative:

USDOT (Federal Highway Administration) has made contact w/ DHS and anticipates (with high confidence) minimal impacts. Fed/local law enforcement have contacted the group (A15 For Action) to mitigate impacts.

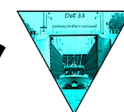
b.  Squadron ONE/JTFES Naval activity for the past week:

- i. DET 1 Indian Point Activity: Federal Safety and Security Zone Patrol/Lower Hudson River Patrol.
- ii. DET 2 Staten Island Activity: Support to USCG Sector NY.
- iii. DET 3 Jones Beach Activity: Support to JTFES and USCG Sector NY. DET 3 will support the USCG and PANYNJ orientation for JFK Airport on 16APR24. The location is Jamaica Bay.

4) LOGISTICS:

a. Status of boat repairs:

- i. Completion of PB 301 repairs is the highest priority. The boat needs repairs to the steering ram assembly as well as bottom paint. Upon completion, this boat will be delivered to DET 3.





- ii. Replacement of engines on LC 350 is second priority. The port Optimax engine has been removed from the boat. The primary control connections exist on the starboard Optimax. We are taking a systematic approach to removing that engine so that the installation of the new SeaPro 300HP engines goes smoothly.
- iii. Repairs to the port engine on PB 300 is the third priority. We are in the process of assessing needed repairs and replacement parts. Verado L6 engines are no longer in production by Mercury Marine, so we are also determining the availability of parts.

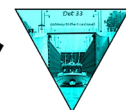
