DESCRIPTION OF MODIFICATION:

- 1. JUSTIFICATION: Request that a Modification be issued to increase allotment by \$4,019,200.00 in the 100% Federal Cost Share of Appendix 1001, ARNG Facilities Program, of the Master Cooperative Agreement for Fiscal Year 2014, and is reflected under its respective cost shared category. Additionally AFP in the 100% Federal Cost Share is increased by \$976,000.00 due to OCO (131 VFRE) transfer from MNOT and increase in MDEP ERVT.
- 2. The Maximum Funding Limitation (MFL-Federal) for this Appendix W912PQ-14-2-1001 for FY-14 is increased by \$4,019,200.00 from \$277,500.00 to \$4,296,700.00.
- 3. The Estimated Cost (AFP-Federal) for this Appendix W912PQ-14-2-1001 for FY-14 is increased by \$976,000.00 from \$19,530,500.00 to \$20,506,500.00.

In accordance with NGR 5-1 Chapter 9, In-Kind Assistance (IKA) is the federal procurement of supplies or services for a State's/Territory's State Military Department through a Cooperative Agreement. In-kind assistance can be federally procured supplies, services, or construction. Services can include real property maintenance and repair.
- 2. Use of federal procurement system to contract supplies, services, or construction does not relieve the state of its responsibility to meet the match or share requirements specified in the appropriate Agreement. 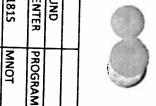
